The Outpatient therapists at CCLH can participate in weekly Interdisciplinary team meetings with the medical director and nursing staff to ensure collaboration and excellent supervision. The therapists have the opportunity to conduct intake evaluations that include assessing the needs of the client and creation of the treatment plans. Therapy sessions address the individuals or family goals in a professional, empathetic, and trauma-informed manner.

**Responsibilities:**

- Provide individual or family services to children, adolescents, and adults.
- Use therapeutic techniques and evidence-based therapies to provide treatment.
- Conduct intake evaluations that assess the needs of the client.
- Create treatment plans.

**Additional Requirements:**

- Act 33 Clearance (PA Child Abuse) **must** be received **prior to hire**.
- Act 34 Clearance (PA State Police Record Check) **OR** the Department of Human Services FBI Fingerprinting must also be received **prior to hire** along with the Act 33 Clearance. The remaining clearance must be received within 30 days of hire.
- Must complete Crisis Management Training and Mandated Reporter Training within 30 days of hire.
- Must be able to complete CPR/First Aid Training.
